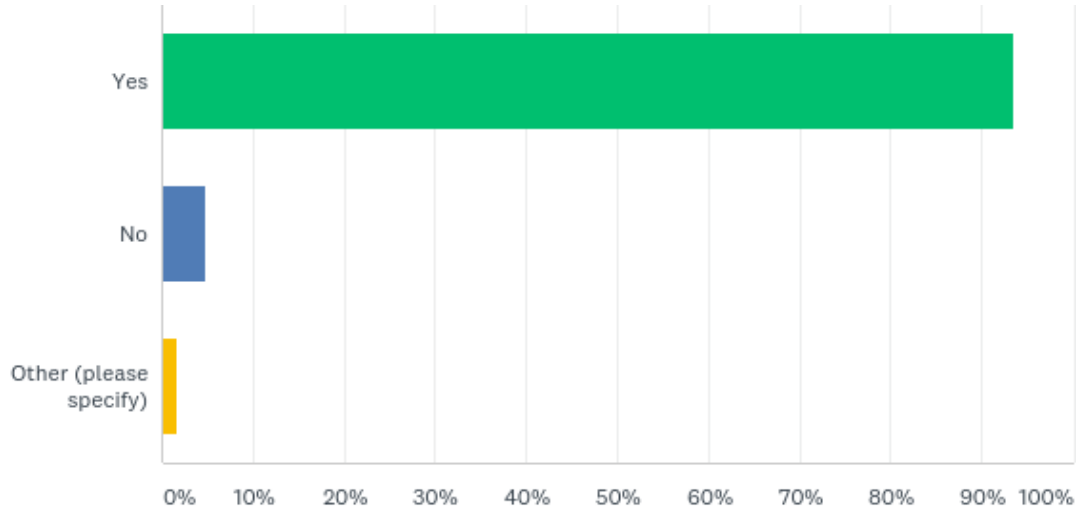
Introduction

For committing to Kinloch and encouraging the TDC team to become fully engaged with the Kinloch community.

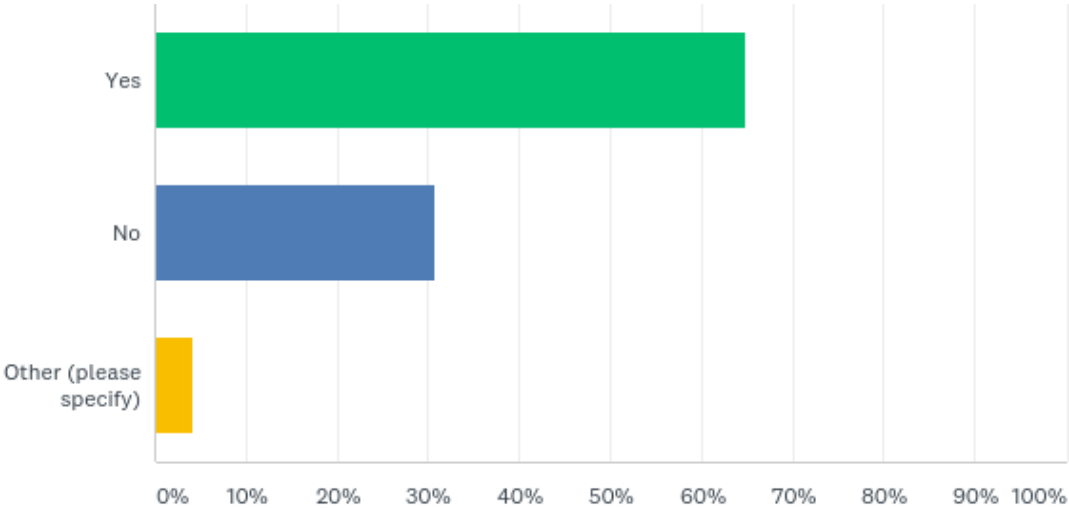
Q1: Do you support the submission for Road Structure Safety for Kinloch Rd and Whangamata Rd?

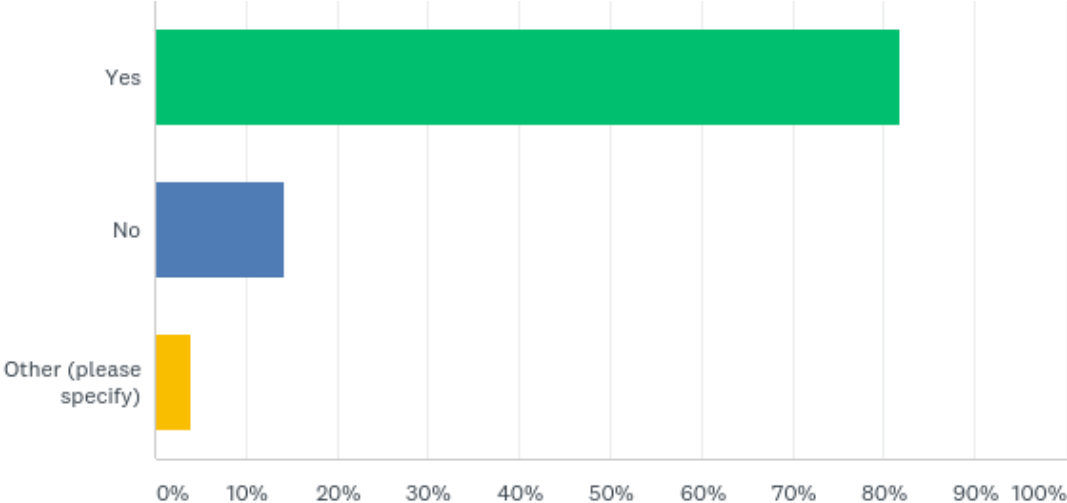
Q2: Do you agree the speed limit within Kinloch Village (from the Kinloch Rd & Lisland Drive roundabout) should be reduced to 40km/hr?

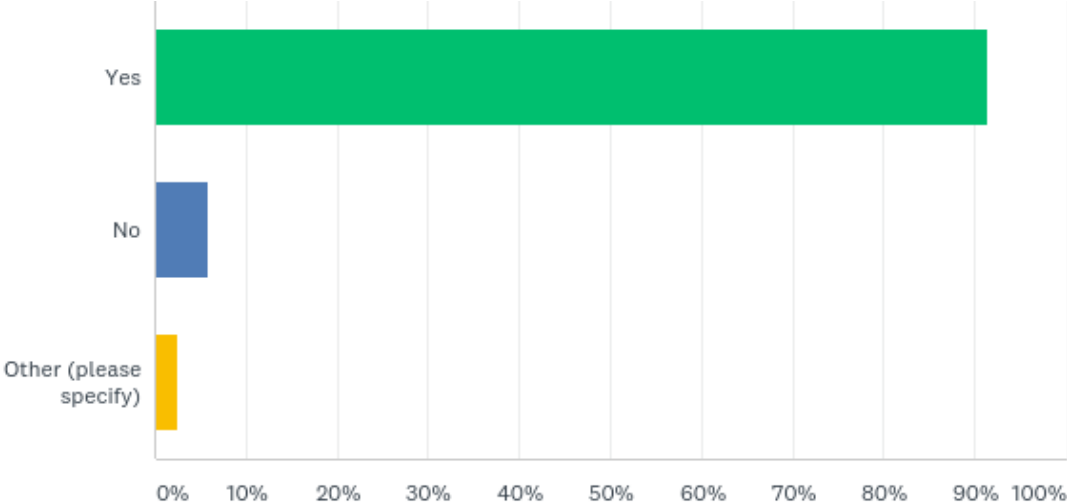
Q3: Do you support the submission for a redesign of the Lakefront (shop side) to improved safety?

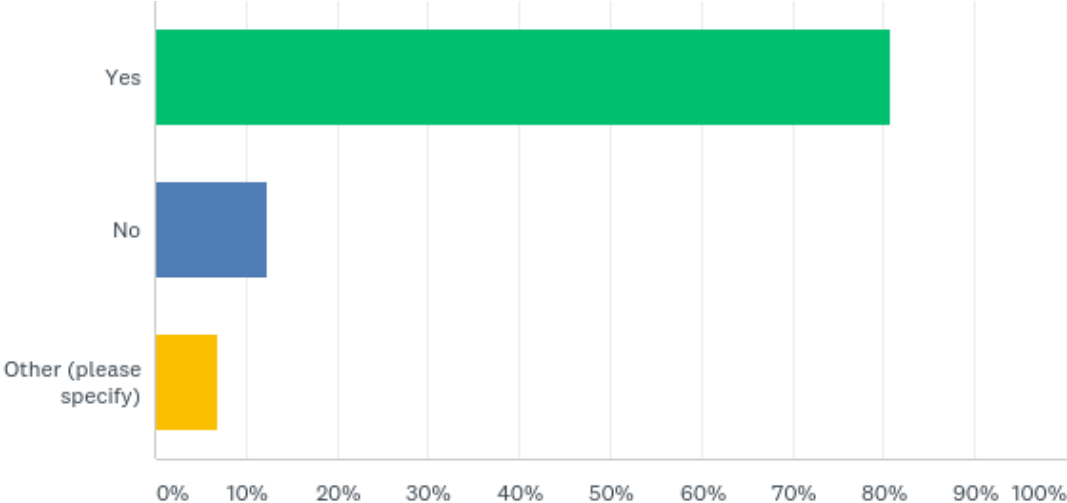
Q4: Do you agree that there should be Walkways designed into all developments in Kinloch, as per the original design of Kinloch?

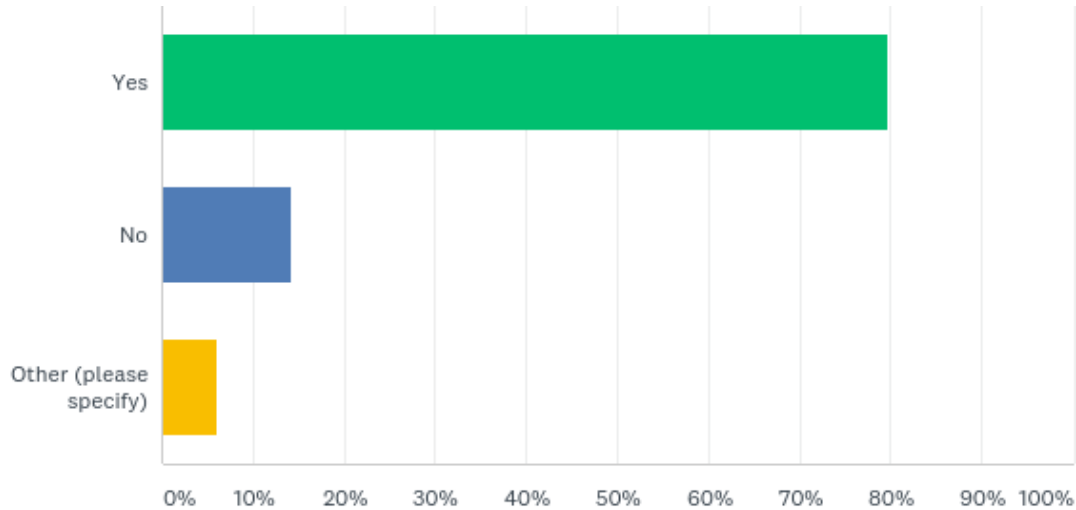
Q5: Do you support the submission for extending the Hall?

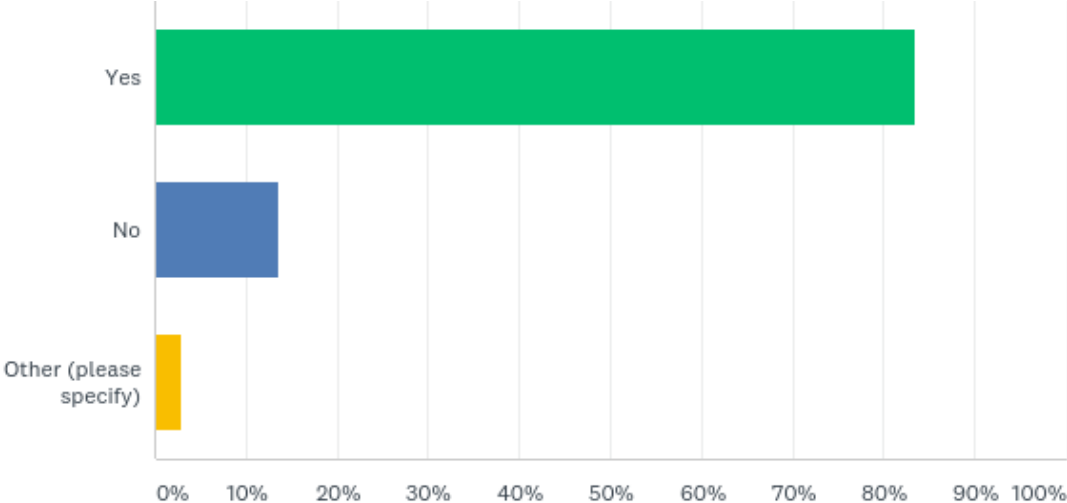
Q6: Do you support the submission for a Community Sports field?

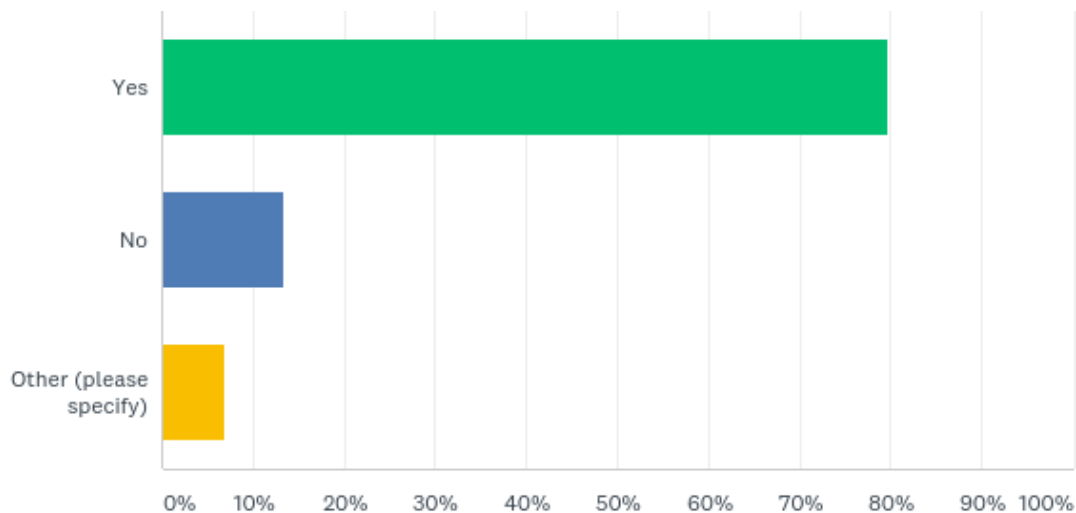
Q7: Do you agree that we need a toilet facility at the far end of the Eastern Beach Reserve?

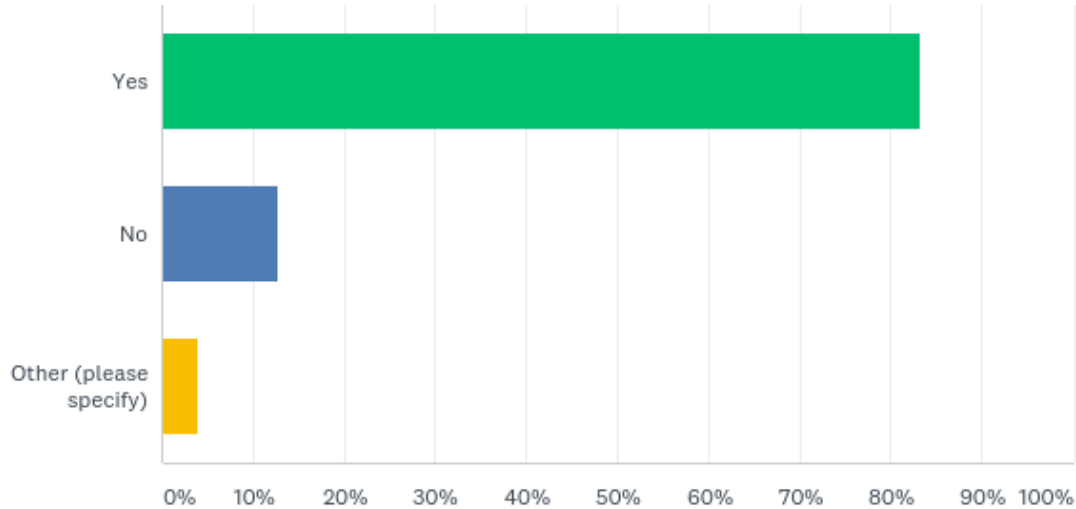
Q8: Do you support the submission for moving the stormwater outlets from the Marina?

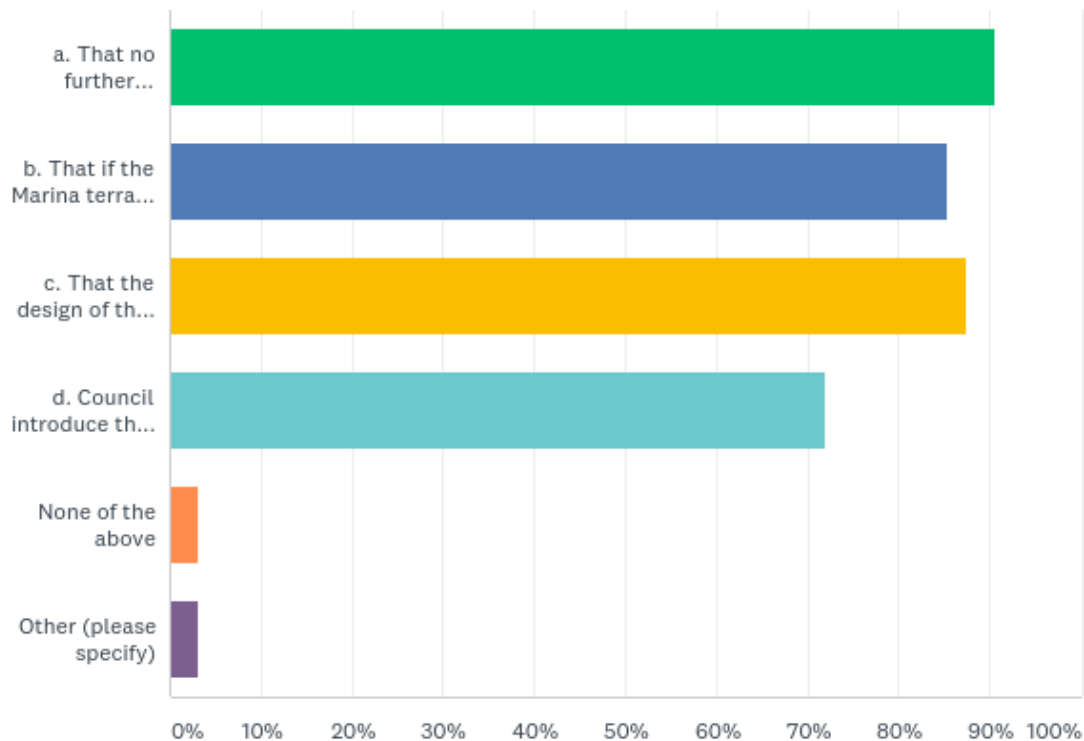

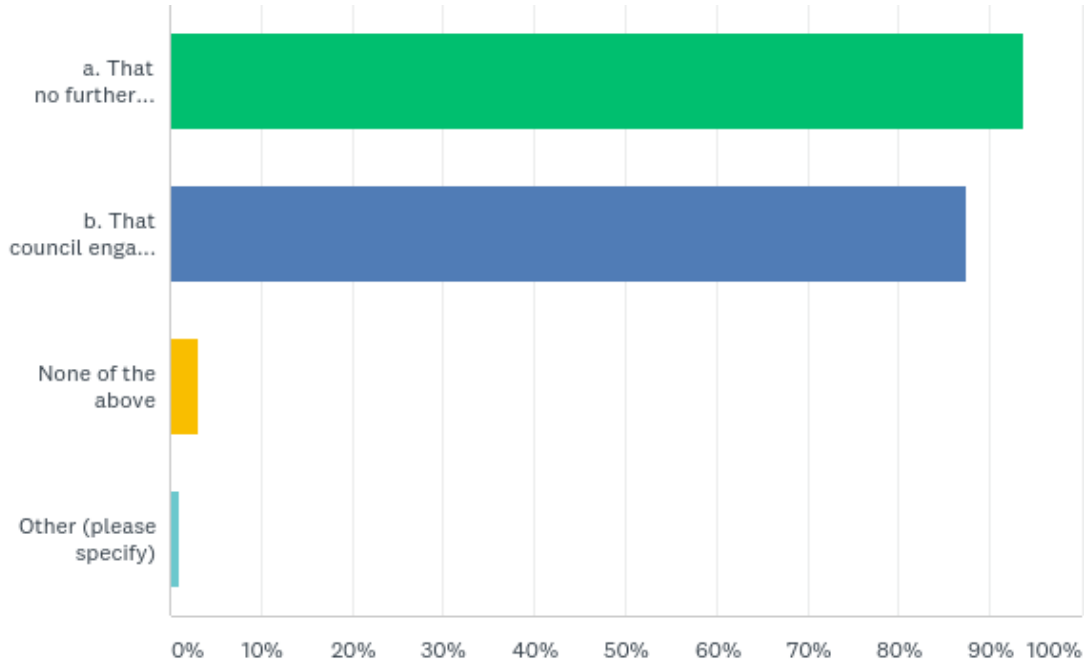

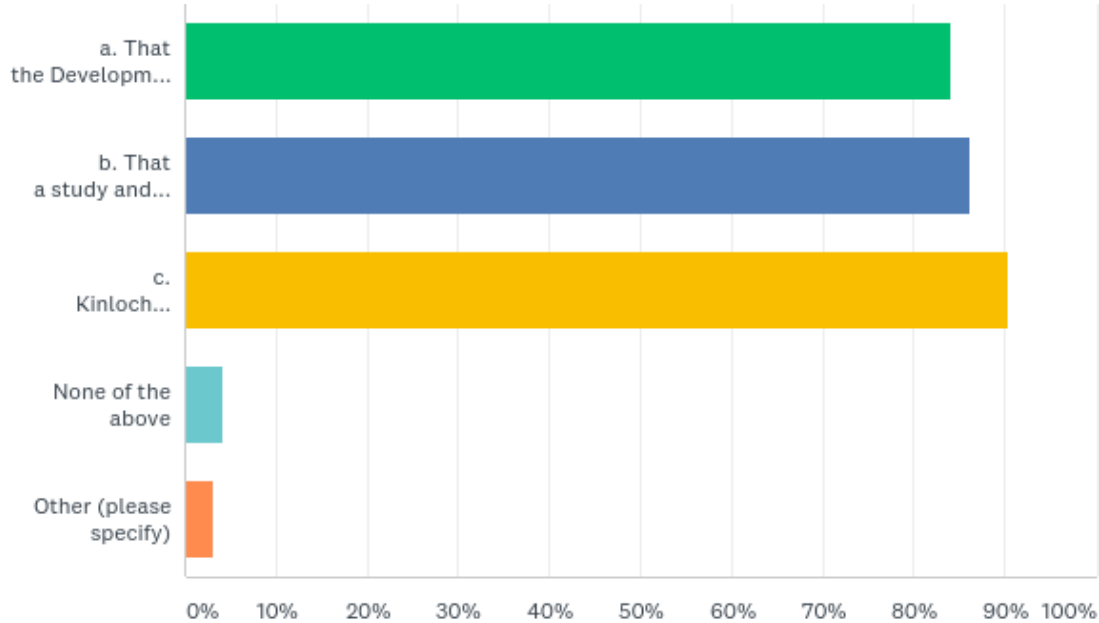
Q2: Please tick all of the boxes that you agree with the statement regarding Wastewater Upgrade?

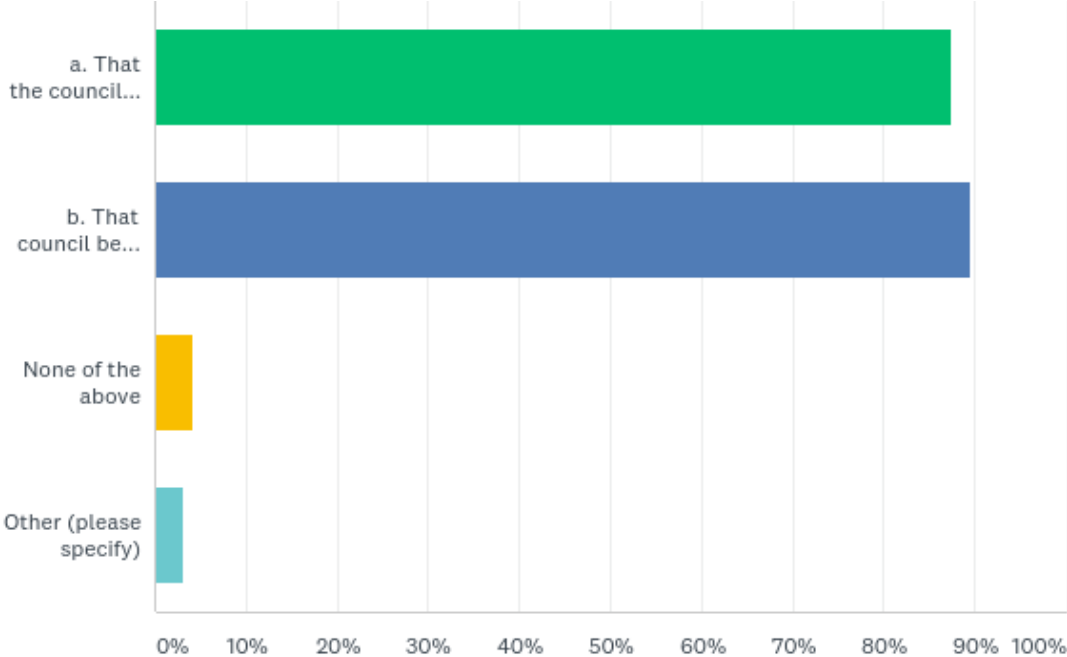

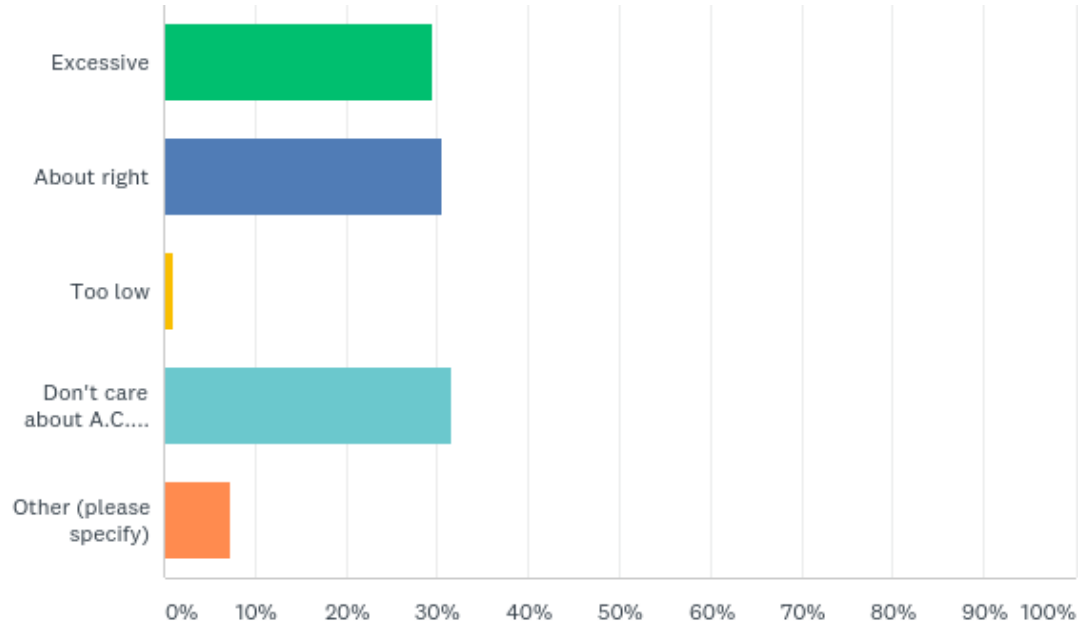
