Kinloch security cameras are in urgent need of servicing as it hasn't been done for two years. We need to get a quote from Alpha Security before they do the job to know exactly how much it will cost.

Beach Disability mats – KCA is awaiting approval from the Tu Wharetoa Trust Board for the use of mats on the beach opposite the Kinloch store. Ron spoke to funders at the Volunteers Expo held over the weekend and believes they will be fully funded.

Proposal for Council - A proposal for the TDC was discussed regarding a co-operative approach for vegetation maintenance between ratepayers adjoining a reserve, and the council.

7. Kinloch Stream Reserves Report

Ross received a letter regarding the replacement of poplars.

The open day with Fisheries and DOC was held on Saturday, with disappointing attendance. Fisheries spoke with Ross, and they are keen to assist with planting, etc and getting rid of monkey musk at Okaia Stream. Hundreds of New plants are to be planted at working bees in the next couple of months.
